Godman Camp – Stats for year for 2021

Update Pollinator Habitat Project

Cecily met with members of the Conservation Commission after Christmas. They will serve as resource for the grant application and suggested controlled burn in that area which is endorsed by landscape professionals.

Cecily will talk with John Delaura, Inland/Wetland Commission, to get blessing for burn. Cecily will reach out to NOMAD to discuss/schedule controlled burn for March.

Soil testing was suggested to ensure the soil in mound between Pollinator Habitat Project and Coan Pond does not have any toxic entities prior to the mound being moved.
